This 4-day course provides experienced auditors with classroom, lab, and field-based training in advanced energy auditing knowledge, skills, and abilities, including: advanced building diagnostics, application of ASHRAE 62.2 ventilation standard, and advanced Quality Control oversight. There are no formal pre-requisites for this course, but students should have at least one year's work experience in energy auditing and have attained BPI Building Analyst And Envelope Professional certifications. Verify compliance of retrofit work performed based on work plans and standards. Use diagnostic equipment to conduct inspections, and develop reports that specify corrective actions to achieve optimal whole house home performance.

Students are strongly encouraged to discuss their own work experiences.

At the end of this course, students are provided with additional resources to prepare for BPI Certification as a Home Energy Professional Quality Control Inspector. Students may schedule their written and field certification tests at any time after the course has concluded.
